ORDINANCE NO: 67B-2013

AN ORDINANCE TO AMEND THE LANGUAGE OF ORDINANCE 67-2011, THE “BLENDON TOWNSHIP CEMETERY ORDINANCE” TO ACCOMMODATE CHANGES IN THE OPERATIONAL POLICIES OF BLENDON TOWNSHIP CEMETERY.

THE TOWNSHIP OF BLENDON ORDAINS:

SECTION 1: PURPOSE AND EFFECT

- 1.1 This ordinance is intended to amend the **Blendon Township Cemetery Ordinance, Ordinance 67-2011.**
- 1.2 The adoption of this ordinance shall amend Section 11 (a) Cremains, and it shall read in its entirety as follows: “Cremains may be buried in a container approved by the Township in a cemetery plot or in the designated Cremains Garden, or in a columbarium that has been installed by the Township within a Township cemetery.”
- 1.3 The adoption of this ordinance shall also amend Section 19 (hh) Prohibited Uses and Activities, and it shall read in its entirety as follows: “Grave markers are permitted to be set up on cemetery plots prior to burial only in Section Tyler. In all former sections, grave markers will not be allowed on cemetery plots prior to the time of burial.”
- 1.4 The language of section 11(a) of the Blendon Township Cemetery Ordinance, 67-2011, and the language of Section 11(a) of the amendment to the Blendon Township Cemetery Ordinance 67A-2012 and the language of Section 19(hh) which were in effect prior to this date are hereby repealed.

SECTION 2: PUBLICATION AND EFFECTIVE DATE

This ordinance or a notice of adoption and summary of the regulatory effect of this ordinance shall be published in a newspaper of general circulation in the Township. This ordinance shall become effective immediately after such publication.


