The building will **not** be used, in whole or in part, for any nonagricultural purpose.

4. I understand this building will be exempt from the State of Michigan Building Code because of its status as a building used for agricultural purposes only. I further understand that exempt status will be lost if this building **is** used, in whole or in part, for any other purpose except agricultural purposes. **In that event, the building will be required to comply with the State of Michigan Building Codes, and one or more permits will have to be obtained at that time and it is also possible that the building may have to be modified, restructured, removed, or moved.**

5. It is understood, and represented to be true by the owner, that no portion of the accessory building is to be used for retail trade. No portion of the building is to be used for the storage of personal property that is not related to the agricultural use of the land on which it is located. No personal machinery, equipment, travel trailers, recreational vehicles or automobiles will be stored within the building and any such storage shall be at the owners' own risk as the Township has not authorized or inspected the accessory building for the same. The owner will not allow anyone other than immediate family members and agricultural employees, if any, access to the accessory building.
