- Supervisor Vanden Berg asked the Board for explanation on who pays for the paving of subdivision roads:
 - Trustee Vander Veen explained that subdivision roads are paid for one of the following ways:
 - i. If the subdivision has private roads they are then paid for by the HOA.
 - ii. Mileage on taxes
 - iii. Special Assessment
 - iv. From the General Fund
- Supervisor Vanden Berg stated that the Ottawa County Road Commission will be adding gravel the both 84th and 76th Ave.
 - Cost \$30,000.00
 - This was ordered last year, but due to gravel shortage was never completed.
 - Trustee Vander Veen pointed out that gravel was not budgeted into the expenditures of the 2019-2020 Budget because the board was not aware that this was an outstanding order from last year.
 - i. The allocation was not carried into the new budget year.
 - Supervisor Vanden Berg stated that he feels that 'the roads are for the people so we should just take it out of the general fund to pay for the gravel'
 - Trustee DeLange stated that there is no question that the roads need the new gravel; therefore, the Board needs to do one of the following:
 - i. The Board needs to come up with a plan of how to pay for the gravel.
 - 1. A public hearing would have to be set to amend the 2019-2020 budget.
 - ii. The gravel order needs to be cancelled.
 - Treasurer Golembiewski agrees.
- ***Motion to set a Public Hearing to Amend the 2019-2020 Budget on May 20, 2019 @ 7:30 pm to pay for gravel application was made by Phil DeLange, support by Greg Golembiewski.***

- Treasurer Golembiewski presented the Board with a preliminary job description and list of benefits concerning the proposed Township Manager Position.
 - Treasurer Golembiewski stated that the Board needed to look at the future of the township and the way that the township is growing it would serve the residents well.
 - Officials come and go but a township manager provides consistency, familiarity and knowledge for the residents.
 - Treasurer Golembiewski wanted to bring the position up to the Board again, as he feels that since it was presented it has been sitting out there with nothing being done and it should be discussed.
- Trustee Vander Veen recalled the original discussion about the possibility of moving to a Township Manager:
 - Kurt Gernaat was being interviewed by the City of Zeeland.
 - The Board decided that they did not want to lose Kurt at the township and decided to increase his wage to at least what he would be able to obtain by accepting a position somewhere else.
 - Unsure if Kurt would stay at the township or not; if he did, what would that position look like?
 - Felt that Kurt offers a special skill set that is a major asset to the township:
 - He is familiar with all of the roads
 - He has and has had more contact with citizens out in the community than most people.
 - He understands the challenges and achievements in the areas of growth in the township.
 - The discussion now needs to be what does the position of Township Manager look like? What does the transition period look like? What does a new fire chief position look like?
 - We need to keep the residents informed of what is going on and welcome and support any comments that the public has.
- **Motion was made to table the discussion of the job description of Township Manager** until the May meeting so the Board has time to review the information that was handed out and think about how we will move forward with the Township Manager position, was made Phil DeLange. Support was offered by Jim Vander Veen upon clarification that all discussion will be with the intent of moving forward with the position, not dismissing it.
